

Another 911 Judgment Nears

56 MILLION LIVES REQUIRED. *Your LIFE may depend on this.*



1. Perhaps on 9-11-2015.
2. Perhaps on 9-13-2015 (what would be on the Jewish calendar *Elul 29*; *see below re Jonathan Cahn's The Harbinger, Isaiah 9: 10 Judgment and The Mystery of the Shemitah).*
3. Perhaps years away.
4. **But based on God's Word – unless we repent GREAT CATASTROPHIC JUDGMENTS WILL COME:**

*“when a land sins against Me by persistent unfaithfulness, I will stretch out My hand against it;.... cut off its supply of bread, send famine on it, and **cut off man** and beast from it” -(Ezekiel 14: 13). That's catastrophic.*

5. As proved below, **that's what the Bible teaches.** Congress -for **America-** believes the Bible is **“God's Word”** which it tells us we *“need to study and apply”* (Public Law 97-280; for proof they're right, see footnote¹). **God takes that seriously.**
6. **How can I predict such a thing? Or have such knowledge?**
7. **BECAUSE: 1) God predicts it in the Bible; 2) I prayed for past judgments that occurred so I bear witness² that God has been bringing judgments on America. Let me explain:**
 1. **GOD PREDICTS GREATER JUDGMENT IN THE BIBLE. READ God's inscripturated Word in Leviticus 26 (part of it is in footnote³ to illustrate the point); Deuteronomy 28; Isaiah 1: 5; 9: 8-12; Jer. 5: 3-9; 18: 11; 51: 11; Ezekiel 14: 13ff, Amos 4,**

¹ America's fathers considered a God centered worldview critical to understand life and government. Their Declaration of Independence: “We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness. That to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed.” God is Supreme Lawgiver (“the laws of nature and of nature's God”), Supreme Judge of men's souls and nations (“appealing to the Supreme Judge of the world for the rectitude of our intentions”), and Supreme Ruler of all (“with a firm reliance on the protection of divine Providence”). American government thus presupposes that all are required to keep God's law, are subject to His sanctions (He will enforce His will on earth as it is in heaven), and are under His all controlling providence. The Declaration further declares government a servant of God to fulfill His purpose to guard the rights He (not government) gave individuals. It declares all men and nations under God. Congress' very first prayer prayed to this Creator God asking Him to act in history by delivering the righteous and punishing the wicked. At King George III's assault on American's rights at Boston, they prayed:“these our American States, who have fled to Thee from the rod of the oppressors and thrown themselves on Thy gracious protection, desiring to be henceforth dependent only on Thee....All this we ask in the name and through the merits of Jesus Christ, Thy Son and our Savior. Amen” was both a heartfelt supplication and a **declared covenant** God takes seriously. We had better keep our promises, vows and covenants with God for He surely requires us to do so. Those who hate you shall reign over you,... [A]fter all this, if you do not obey Me...I will punish you **seven times more** for your sins. ...your land shall not yield its produce... ‘Then, if you walk contrary to Me,... I will bring on you **seven times more plagues**, according to your sins.’ ...wild beasts...shall rob you of your children,...and make you few in number; ‘And if by these things you are not reformed by Me,... I will punish you **yet seven times** for your sins.... I will bring a sword against you that will execute... vengeance... within your cities I will send pestilence;...[A]fter all this, **if you do not obey Me...I, will chastise you seven times** for your sins....You shall eat the flesh of your sons, and...daughters....and My soul shall abhor you.’**

Matthew 11, Luke 12: 48, Revelation 9: 20-21; 21: 8. These and others **WARN that when LESSER judgments are ignored, God brings GREATER judgments!** Deut 18/Matt. 18 say the testimony of 2 or 3 witnesses establishes truth. In God's providence, it is uncanny God brought before America THREE so called leaders, all – wittingly or not- uniting in a vow of brazen defiance against God's 911 judgment for its sins. America's sins are strikingly similar to the sins God indicts Israel for in Isaiah 1 save for technological changes. For Israel's sins, God judged by Assyrian's vicious attack. Rather than acknowledging their sin, turning back to God to mercifully forgive and receive them through His promised Messiah, Israel in **Isaiah 9:10** utters a defiant vow that it will save, bless and keep itself. Of all the verses in the Bible, those very words were uttered the day after 911 by Senate Majority Leader Daschle. Those same words were again uttered by John Edwards later. More recently, again by Obama. These 3 witnesses bear witness against America. In response to God's judgment we are not repentant, but defiant, determined to annul, ignore and overrule Him and His will. **Have we any indication what God's response could be?** Being **merciful** to save Jew and Gentile who call on Him through His Anointed Son Y'shua/Jesus, He is as well **just** to all those who defiantly rebel against Him and His King (Psalm 2). Because we like Israel repeatedly utter the same words of Isaiah 9: 10 re God's judgment, His response in Isaiah 9: 11-14 has application to America: ***“Therefore the LORD shall set up the adversaries of Rezin against him, and spur his enemies on, the Syrians before and the Philistines behind; and they shall devour Israel with an open mouth. For the people do not turn to Him who strikes them, nor do they seek the LORD of hosts. Therefore the LORD will cut off head and tail from Israel, palm branch and bulrush in one day.”***
TERRIFYING JUDGMENTS are ahead for America.

2. **I CONFIRM GOD'S PAST JUDGMENTS AS AN EYEWITNESS.** I swear to God I know as a firsthand personal witness that God judged America by 911. How do I know? **Because the judgment came in direct answer to prayer.** As Elijah asked God to judge Israel with drought **BEFORE** the drought, so **I asked God to judge America with 911's Twin Towers and Pentagon attacks ½ hour or so BEFORE the attacks.** Why? For God's glory and people's eternal salvation. **1) Because** we SAY “In God we trust” but trust in money and our own military might etc so the Creator of the universe' purpose in making us glorify and enjoy Him is resisted; **2) because** we had gone on murdering tens of millions of unborn babies; **3) because** hundreds of millions were on their way to hell. Like Elijah, frustrated that despite decades of men of God calling Israel and doing everything they knew how to turn the nation back to God, he finally resorted to praying earnestly (James 5: 15-18) for judgment with the desired result that God might be praised and people saved. In similar circumstances, I *with tears* cried to God that IF it was right in His sight, the right time, He would cause us to see **just a DROP of His wrath** so we might fear Him, turn to Him and find forgiveness in Jesus. **ADDITIONALLY:** God has also graciously **saved many** as well as **protected, provided, multiplied, guided and blessed** in answer to my and other's prayers - see www.anchoroftruth.org). **I and or others asked God for 2007's worst drought in Alabama** (see congregational signatures), **2008's Great Recession, the pope's resignation and 2 lightning strikes on the Vatican** to show Jesus wrath against that false church, its false gospel leading

millions to hell and its blasphemous anti-Christ claims concerning John 14: 6. Praying for a limited judgment with a merciful end is like that taught, done and approved of (given the right circumstances) by Moses, Elijah, David, Jeremiah, Jesus, Paul, the apostles, saints in glory and church history and all of this is proved with supporting Scriptures as well as supporting evidences (I am **in process** of loading to the website) at www.anchoroftruth.org . For proof that the Bible and Jesus' claims to be God's Son and Messiah are true, see www.godblessisraelministries.com). **I swear to God⁴ under penalties of perjury I am not lying and these things are true!**

8. Our greatest sin: **IDOLATRY**. Saying “*In God we trust*” while we trust in money (our Twin Towers represented it). In our military might (our Pentagon represented it). In immoral pleasure as represented by “\$57 billion per year” in porn sales - more revenue “than the combined income...by pro football, baseball, and basketball”. In government as represented by our ungodly fear of it. Proverbs 16: 4 says: “The LORD has made all for Himself, yes, even the wicked for the day of doom.” **GOD MADE US AND THE WHOLE UNIVERSE FOR HIMSELF! Macro evolution is not true (see footnote⁵)**. Our idols not only crush the loving heart of God the Father who created us to glorify and enjoy Him forever, but also justly and fiercely anger Him (cf. Ezek. 5: 12; 6: 9-14). He will receive glory either by our salvation or damnation. Judgments (and hell) prove that treason against God is utter insanity. We should fear, not defy, God. We

4 The Heidelberg Catechism (from the Protestant Reformation, 1563) gives this summary on an oath: Q & A 101 “Q: “But may we swear an oath in God’s name if we do it reverently? A. Yes, when the government demands it, or when necessity requires it, in order to maintain and promote truth and trustworthiness for God’s glory and our neighbor’s good. Such oaths are grounded in God’s Word¹ and were rightly used by the people of God in the Old and New Testaments.”² (1 Deut. 6:13; 10:20; Jer. 4:1-2; Heb. 6:16; 2 Gen. 21:24; Josh. 9:15; 1 Kings 1:29-30; Rom. 1:9; 2 Cor. 1:23). Q & A 102 “Q. May we also swear by saints or other creatures? A. No. **A legitimate oath means calling upon God as the only one who knows my heart to witness to my truthfulness and to punish me if I swear falsely.**¹ No creature is worthy of such honor.”² (1 Rom. 9:1; 2 Cor. 1:23; 2 Matt. 5:34-37; 23:16-22; James 5:12).

5 Go to www.answersingenesis.org or www.creation.com which exposes the deception of evolution and provides scientific evidence confirming the truth of the Bible that God created the universe in six ordinary days. Macro evolution is neither proveable nor does it fit with the Bible which is infallible truth, therefore it cannot be true. To overcome trained skeptics and natural unbelievers about the truth and authority of the Bible: consider how obvious it is from the creation all around you that there is a Creator God. (See Psalm 19/Romans 1:20). As Ken Ham says: origins is history (thus historical, not observational science), yet we're in the present. So people try to understand the past from the present. No matter how much we know, there's so much more to know and we don't and can't even know how much more we don't know. Ultimately, there is only one way to be sure of something in the past: if someone who knows all things has always been there and cannot lie will reveal the truth to you. That Someone is God and the Bible claims to be His written Word. Through the prophet Isaiah (41:21ff) the true, only and living God challenges idols and idol worshipers to declare the **past** or the **future** infallibly. They can't do it which shows they are nothing but lies but He alone is the true God: “Present your case,” says the LORD. “Bring forth your strong reasons,” says the King of Jacob. “Let them bring forth and show us what will happen; let them show the former things, what they were, that we may consider them, and know the latter end of them; or declare to us things to come. Show the things that are to come hereafter, that we may know that you are gods; yes, do good or do evil, that we may be dismayed and see it together. Indeed you are nothing, and your work is nothing; he who chooses you is an abomination.” Either we presuppose the truth of God's word (who never lies but upholds the universe with utter faithfulness and reliability) or man's (everyone of us has lied or been unfaithful at some point). Man tries to work from the present to the past to determine with certainty what happened. But God proclaims what happened in the past and everything in the world fits with what God says- makes sense because its His world and His word. This **alone** can give certainty to man about past, present and future as well as eternity. Again, God claims He alone is God and can do so (Isaiah 43:9; 45:5, 14, 21; 46:8-13). Evolutionists and secular scientists say “bajillions of years ago there was by pure chance a BIG BANG!, a great big explosion, which by chance brought about all the complexity of the well ordered universe. They believe that?! What great so called “faith” they have. But true faith is based on certain knowledge. They have no certain knowledge or proof of their claims (may God have mercy on them). They weren't there, they have witnesses sworn under penalties of perjury. Rejecting God's word, they endanger their body and soul for an eternity in hell on the total guess Darwin's THEORY (not fact) of macro evolution. We have no observational science proving it nor can their be since origins are in the past. Truly, as Psalm 147:19-20 and Romans 10:12 show, despite the creation evidence all around us making us inexcusable for our sins, unless God graciously revealed Himself to us in His word, we could never rightly or personally know Him or know how to be forgiven for our disobedience to this Creator's will nor how to be saved from sufferings or death. Romans 10:12 shows that faith to believe Him and be rightly related to Him comes by hearing the Word of God. So, in love for your eternal soul and your temporal well being, I share God's word herein.

trust in false gods that cannot save: military, homeland security, our own works. We think we don't need God's Son to save us. BUT GOD in Psalm 2, Amos 9, Isaiah 11 & 49 declares such a response utter insanity. He assures there is no escape from His wrath. He also proclaims His determined and gracious purpose: that because of His *extreme* love in giving His Son and Servant to suffer *extreme* humiliation and death to redeem Israel and the Gentiles, it is the Father's *extreme* plan and determined purpose to *extremely* glorify that Son and Him alone by giving Him the nations as His inheritance until *"the earth shall be full of the knowledge of the LORD as the waters cover the sea"*. This is the Creator's world. It is His purpose to reward His Son. No purpose of His can be reversed (Isaiah 43: 11-13; 49). He turns His foe's evil to good to glorify Him and bless His people (see the story of Joseph - www.godblessisraelministries.com).

9. Another great sin: a **holocaust of 56 million MURDERED- our own babies!** Scripture shows a **sword hangs over America justly demanding 56 MILLION Americans lives! Will one of them be yours?** I hardly dare utter it, I *grieve* to say it, but just read the Bible and see what I say is true: God's eternal standard is: "life for life"! In Genesis 9: 5-6, after Noah's global flood - brought on by circumstances similar to America's -violence, murder, corruption - God said: **"SURELY for your lifeblood I WILL DEMAND a reckoning'... Whoever sheds man's blood, by man his blood SHALL be shed; for in the image of God He made man."** Scripture repeats this life for life requirement all the way to Revelation. See a few at: Exodus 21: 22-25, Numbers 36: 9-34, Deuteronomy 21: 1-10, Jeremiah 19: 1-15, Matthew 23: 28-39, Revelation 6: 9-11 et al! It is fearful to read that so much bloodshed can occur that God will **require at least** some horrifying degree of requital judgment as in 2 Kings 24: 1-4: the LORD **"sent [enemies] against Judah to destroy it....Surely at the commandment of the LORD..., to remove them from His sight because of the sins of Manasseh [Obama is like him],...and also because of the innocent blood that he had shed...which the LORD would not pardon."** After 56 MILLION, I don't know how we could not be at that point! God requires lawful authority execute a human life every time an innocent human life is murdered. But, **MOST in our government** have been involved (passively or actively) in justifying, protecting and allowing America's holocaust no less than Nazi Germany's government! Woe to us! Our sin is greater than the Nazi's who slaughtered **6 million** Jews in the Holocaust⁶. That was too small for us- we had to add another **50 million** innocent unborn lives whom God in Scripture repeatedly calls "*child*" (Genesis 25: 21-22; Luke 1: 35-45). Genesis 38: 24 shows there is **no excuse** in cases of incest or rape either. Why should the child die for the father's sins?! **The Most High will enforce His law Himself.**

Like the Nazi Holocaust based on racial profiling and emotional anti-semitism, America's ongoing unborn holocaust is based on emotional profiling: are these humans wanted as well as somewhat racial (especially against blacks whom Margaret Sanger considered to be like weeds).

12. Though I warned Bush and media (see evidence on www.anchoroftruth.org) that 911 was **just a drop** of God's justice (we deserve much more), they ignored God's message and warned no one! So now the cup of wrath is readying to be poured out! On 911, I told the Lord I united my voice with the little one's whose blood was crying out for vengeance. I asked for **just a drop** of requital. Look what happened. If 911 was a drop, what more does America have coming? Does the blood of the murdered unborn **really** cry out to **the Governor** of the Universe **for vengeance**? READ Gen. 4: 10, Deut. 21: 1-9, 2 Sam. 21: 1-9, Rev. 6: 9-11 and see if they do not cry out for "life for life" requital. *There is an ongoing, deafening, heart-breaking cry of 56 MILLION babies rising to God's throne - EACH asking their life - each one of them - be requited.* Do you think the gracious and just God will respond like our "holocaust-protecting judges" - yawning, bribed, fearing man? As Abraham said: "will not the Judge of all the earth do right?" Counting accomplices- spouses, boyfriends, parents⁸ the number may be greater than 56M! Will you laugh at this? **God's words are always fulfilled. Cities like Sodom, Gomorrah, countries like Nazi Germany destroyed. Will America -** whose sins are greater in view of its greater light- **escape catastrophic judgment?** The Just Judge of all the earth declares He will by no means leave the guilty unpunished! Again, He declares: "when a land sins against Me by persistent unfaithfulness, I will stretch out My hand against it; I will cut off its supply of bread, send famine on it, and cut off man and beast from it (Ezekiel 14: 13). If the **Judge of all the earth** says that about "**a land**" or **any land**, how much more about America? **Luke 12:47-48** declares: "that servant⁹ who knew his master's will, and did not ...do according to his will, shall be beaten with **many stripes**. But he who did not know, yet committed things worthy of stripes, shall be beaten with few....**to whom much is given, from him much will be required**". Scripture even says there can come a time when a nation like America – the only Gentile nation that for all purposes repeatedly covenanted with God - after **great knowledge** of Him and great blessings from Him, because it rebelliously turns from Him, refuses His loving gospel calls and warnings to repent, insanely continues despite His judgments– AIDS, tornadoes, hurricanes, fires, floods, earthquakes, broken homes, terrorism, loss of liberties, 911, 2008, Obama-nation - may come to that place where **God** tells His people "don't even pray for it anymore" (Jeremiah 7). Where He says "there is no remedy" (2 Chronicles 36: 16) and so pours forth furious destruction.

13. **If these great sins were not enough to make God furious, disgusting, enslaving lusts further anger Him!** All sins anger God (Psalm 7: 11) and all must be repented of to be saved (Ezek. 18: 30; 2 Cor. 7: 9-11), yet some sins are more **heinous**. One that signals a culture's being on the brink of devastating judgment is toleration or even approval of homosexuality. Scripture shows lands that tolerate such can quickly find incredibly devastating wrath falling upon them - read Genesis 19, Judges 19, Isaiah 1, Romans 1, Jude 7. The Supreme Court's recent case blesses what God has cursed and acts as though God's word and acts can be



disregarded! How dare we?! God judged Sodom with fire that represents hell (Jude 7) for just this sin! Who do we think we are?!

14. **All this seriously urges us cry out desperately and beg God for Jesus' sake to graciously forgive**



us! To quickly obey Psalm 2's command to trust and obey Jesus. To require our public servants to bow before King Jesus! He says: "**Repent...or you will perish**" (Luke 13: 1-3) and "**today is the day of salvation**". **Tomorrow may be late FOREVER!**

15. **Will God show fierce anger against us again? After refusing to repent after 911, and again in 2008, what ASSURANCE do you have He won't in 2015 or thereafter?** I assure you by Scripture and my testimony, we are under judgment. **In 2008**, because despite my earlier informing Bush and the media of my prayer for God's 911 judgment, neither Bush nor the media did their God give duty to inform America of this or to call it to repent (cf. Jonah). Because 911 was only a memory, NYC, DC and Iraq far away, Americans took their Creator no more seriously than before 911, so I prayed to God again (this time more sparingly) hoping that perhaps by feeling some degree of judgment *personally in our pocketbooks* we might be awakened to our need for God. I prayed God would not let anyone starve, but would basically cause our economy to grind to a halt. After that prayer, the Great Recession resulted (see www.anchoroftruth.org).
16. **God gives all of us a VERY SERIOUS duty to warn others if we see them endangered.** Ezekiel 33: 1-11 calls me to be a watchman who sounds the alarm BECAUSE I have seen judgments occur, realize sadly we have not repented, and foresee from Scripture's words that greater judgments thus are coming. **I SOUND THE ALARM! Woe is me if I do not preach the gospel and sound the alarm!** - I could incur blood guilt if any die physically or eternally.
17. Most don't fear God and Bible knowledge is outlawed (as I heard of in Russia as a child - like them, not in churches, but by cruel government agents in schools, courtrooms & holocaust camps/abortion/murder providers. You may find a heart tendency to suppress these truths and to hold onto unrighteousness (see Romans 1). **Don't.** Think on and allow God's goodness and grace to draw you to Himself: He Himself created you, upholds your life each moment, gives you food, water, breath, and *every good thing!* The Most Amazing Thing: **He so loved the world that He gave His only begotten Son to die the death sinners like us deserve so we can LIVE FOREVER with Him!** But whether you agree or not, you must realize your thoughts about God ultimately don't matter. He isn't running a popularity among sinners contest. He is right, just, true, holy, good, gracious, and loving and pure. In His throne-room the angels never stop crying out day and night: "*Holy, holy, holy is the LORD God Almighty who was, and who is and who is to come*" (Isaiah 6; Revelation 4). Impugning or sinning against God's character, law, justice, goodness, mercy or truth is **eternally fatal** - unless you repent and Another agrees to bear your sin & punishment as your Surety. **Good news!**- there is such a One- Jesus!
18. You can write me off as a Bible nut or say "America's too strong" or "too special (to who? God?!)" to suffer destruction. Read Lamentations how other the Jewish people thought similar things like that before suffering punishment. Do what is right: repent of sin and trust the only Savior who can make you right with God and rescue you from God's judgment. **Proverbs 22:7** urges you to prepare for judgment which includes spiritual and obvious physical preparations.



19. **Believing Rabbi Jonathan Cahn, author of Harbinger, Isaiah 9:10 Judgment and ...Shemitah stated that PERHAPS God could judge us **9-13-2015**. While I do **not necessarily** agree with all he says, I am **thankful** God brought this controversy so I could share further the message that has burdened my heart **for years**. A few thoughts about the "Shemitah" (Hebrew for release):**

1. from Leviticus 25 et al¹⁰ **it is clear God requires releasing people from perpetual debt**; He didn't create man to be a slave/servant of work or others, but His happy servants; those who know Him as Savior enjoy 1/7th of their time off;
2. especially for a nation that claims the Bible as the "royal law of liberty", whose founders

- declared their liberty came from their Creator whose Son Jesus they prayed to as God's Anointed Savior¹¹, which inscribed Leviticus 25: 10 on its Liberty Bell, and which espouses "liberty and justice for all", such **perpetual debt service/slavery is just plain wrong**;
3. it was in the wake of 911 that God led me to realize **commercial loans are fraudulent** (see proof that this is in fact the case in [footnote¹²](#)).
 4. if the **general equity** of God's ceremonial and/or civil law in Leviticus 25 teaches us that for His redeemed people He forbids perpetuated debt **even when that debt is true and lawful, how much more would He not forbid fraudulent loans/debts AND require their cancellation!?**
 5. Having rejected God, His word, His Son, grace and law, we are suffering. Our sins are taking their toll on our lives, families and economy. We are slaves in a land of liberty akin to Israel

God's church summarized His law in saying His law against stealing requires everyone love their neighbor as themselves by trying "by all just and lawful means, to procure, preserve, and further the wealth and outward estate of others, as well as our own." (**Westminster Larger Catechism**). The Declaration of Rights from the **1780 Massachusetts Constitution** is still in use today (authored by Samuel Adams, John Adams and John Hancock) and bears similar Christian principles in Art. 1: "All men are born free and equal, and have certain natural, essential, and unalienable rights; among which may be reckoned the right of enjoying and defending their lives and liberties; that of acquiring, possessing, and protecting property; in fine, that of seeking and obtaining their safety and happiness." There are 10,000 proofs that America was set up on biblical principles (see some herein). A frequent rallying cry of the War for Independence was: "We will have no other king than King Jesus!" God's word in the Holy Bible shows He created precious metals like gold, silver and copper to be used as money and Jesus confirms this when sending out His twelve apostles in the way He described what "money" was: "Provide neither gold nor silver nor copper in your moneybelts, nor bag for your journey, nor two tunics, nor sandals, nor staffs; for a worker is worthy of his food." (Matthew 10: 9-10). They were worthy of being provided for due to their work, and needed not provide for themselves. But as sandals attire feet, so gold, silver and copper are money. Will we trust our good Creator knows what is best for us, or will we show by disobedience we somehow imagine ourselves wiser than He? The late **Dr. D. James Kennedy** said that the framers of America's Declaration of Independence and the original Constitution wanted to avoid seeing America oppressed. They "knew that because of man's sinfulness and greed, there was his tendency to inflate money. The Old Testament had warned them about that. We read in Amos 8: 5, "Saying, When will the new moon be gone, that we may sell corn? and the Sabbath, that we may set forth wheat, making the ephah small, and the shekel great, and falsifying the balances by deceit?" One of the things condemned in the Old Testament is making the shekel great—inflating the money—and thus using deceit in finances. They knew this, as Washington did, and were afraid of inflating money. You may remember that during the Continental Congress, which had existed from the Revolution in 1776 up until the time of the Constitution in 1787, they had printed money. This paper money, called the "Continental," had become worthless. You have probably heard the expression, "not worth a Continental." The Continental by this time was worth less than a penny because of inflation. They knew that there must be inflation-proof currency. Therefore, the United States government was not empowered to print money. It could "coin money" out of gold and silver or print bills which were redeemable in gold or silver, but it could not print worthless paper. Now, because of various court decisions, the government is able to do that, and we suffer the rigors of inflation off and on. The only way we are going to get away from that permanently is to return to the system which the Founding Fathers gave us." (Dr. Kennedy's sermon "**The Bible and the Constitution**"; Coral Ridge Ministries). Use of currency without gold or silver backing is against God's law and against America's founder's intent. Their Constitution requires America's government to use gold and silver for currency (at least to back it). But our currency is not backed by gold or silver today. Dollar bills used to have written on them: "redeemable in gold or silver upon demand by the holder", but not anymore. This means the government prints many worth-less (than they otherwise would be if backed by gold and silver) "dollars". The effect is to steal the hard earned work and wealth of Americans for basically nothing in exchange. A book showing this violation of Scripture and the Constitution is Rev. Peter Allison's **Dollar Noncents** (I urge you to get and read it). He not only documents the immoral, unconstitutional gradual change from gold and silver to our current fiat currency, but shows how on top of that form of fraud, another fraud occurs in commercial lending: "Federal reserve notes are an attempt to get what you produce and never pay....The respected Hoover Instituted scholar, Athony Sutton had this to say about the Federal Reserve, 'Warburg's revolutionary plan to get American Society to work for Wall Street was astonishingly simple. Even today academic theoreticians cover their blackboards with meaningless equations and the general public struggles in bewildered confusion with inflation and the coming credit collapse, while the quite simple explanation of the problem goes undisclosed and almost entirely uncomprehended. The Federal Reserve is a legal private monopoly of the money supply operated for the benefit of the under the guise of protecting and promoting the public interest.' The mechanism by which all this occurs is as interesting as it is absurd. When the smoke and mirrors are removed, it is really very simple. We will discover a situation that is not at all that different from the type of illusions created by the Wizard of Oz which Toto the dog revealed when he pulled back the curtain. The only problem is that Toto has not yet arrived. **WHERE DO BANKS GET WHATEVER IT IS THAT THEY LOAN** If you are like I used to be, you probably think that banks accept deposits from people who have money and then loan those deposits out to others needing the money. But apparently, that is not what we do today. According to the monetary authority for the United States, in *Modern Money Mechanics*, they say, "Banks can build up deposits by increasing loans and investments." Now I am a simple fellow. I know what deposits are: they are the piles behind the barn. If my neighbor comes over to borrow some deposits, the pile gets smaller. I think most children could figure out that when you loan something, you, the lender, have less of whatever it is that you loaned. But the Federal Reserve is saying that they can increase their deposits by loaning. They

(read Nehemiah 5 & 9).

6. The judgments of 911 and 2008's Great Recession – in light of the Scriptures – are wake up calls, which, combined with the preaching of the good news of Jesus, call EVERYONE (bankers and government involved in floating and enforcing fraudulent loans too) to **REPENT of their sins and BELIEVE on God's Son Jesus**. Jesus commanded: “do not defraud” (Mark 10: 19; cf Leviticus 19; Hosea 7: 1; Acts 13: 10; Colossians 2: 18 (“let no one defraud you”); James 5: 4 et al)).
7. So, even apart from the issue of whether the 7th year law requiring of Israel a release from honest, non fraudulent debts, and even apart from whether God is following the Lev. 25 7 year timetable or not, **His moral law** (which binds all men and nations) **requires: 1) releasing** from and canceling ALL fraudulent loans (see Lev. 19; cf. the Exodus; 8th

must not be loaning deposits. They are actually loaning the promise to pay or an IOU. They simply tell the borrower that they will honor his checks for \$1000 over the amount currently on deposit. This is not my analysis. Modern Money Mechanics says, “Of course they [banks] do not really pay out loans from the money they receive as deposits. If they did this, no additional money would be created. What they do when they make loans is to accept promissory notes in exchanges for credits to the borrower’s transaction account”- that is what they call your checking account. Later they reiterate, “Loans are made by crediting the borrower’s deposit account, i.e., by creating additional deposit money.” What is a credit to your checking account? A book entry made with their pen or their computer. They do not even give you an IOU or note which is a promise to pay. Of course the irony of it all is that it is your integrity that is questioned when you apply for a loan. No one ever thought to question their integrity.”Debt, as opposed to salt, tobacco, or gold, is being used as money. In essence, debt has been ‘monetized.’ Commercial banks are one of the ways debt is monetized. For example, suppose you come to a commercial banker for a loan of \$1000 to build an outhouse with two electrically heated seats. The banker agrees to grant you a loan at 10% annual interest. In making this loan, he does not actually loan you any commodity- any money. He does not even loan you any Federal Reserve Notes. He simply makes a book entry with his pen- or nowadays with his computer. There is nothing that is loaned; no tangible substance changes hands. The banker simply increases the total on your account by \$1000 and authorizes you to write checks against this increased total. In effect you print your own money as you write the checks.” **Further quotes from the bankers own mouths prove banks do NOT loan out their depositor’s funds as most are led to believe:** 1) an International Monetary Fund working paper states: “under the present system banks do not have to wait for depositors to appear and make funds available before they can on-lend... **This fact can be verified in the description of the money creation system in many central bank statements**”. 2) **The Federal Reserve Bank of Chicago states: “what they do when they make loans is to accept promissory notes in exchange for credits to the borrowers’ transaction accounts.”** 3) **The Bank of England’s Quarterly Bulletin of 2008 states: “banks extend credit by creating money.”** 4) **The Federal Reserve Bank of New York publication, I bet you thought states: “Commercial banks create checkbook money whenever they grant a loan, simply by adding new deposit dollars to accounts on their books in exchange for a borrower’s IOU”.** 5) **The Federal Reserve Bank of Dallas’ publication Money and Banking states, “banks actually ‘create’ money when they lend it.”** 6) **Former attorney of the Federal Reserve Bank of Cleveland states, “banks deposit promissory notes with the intent of treating them like deposits of cash.”** 7) **Walker Todd (former Federal Reserve employee) when asked in court: “Does the bank create money out of thin air?” answered: “Under a fractional reserve banking system, that is in effect what happens.” All these banking authorities say they ‘create money’ when they lend it.** The 5 minute link below exposes only the tip of the iceberg of the banking fraud involved. It would seem reasonable that one would not want to go seeking such a commercial loan again after this knowledge. **This youtube “Bancorruptcy” exposes the fraud using the bankers own words and documents:** https://www.youtube.com/watch?v=QHKdxAVW-_U What these quotes show is that you create the money by your signature (a promissory note), hand it to the bank not realizing its value on the market as a negotiable instrument, and you participate in a system (unknowingly at least up until now) that treats them as though they are god and can create something out of nothing - technically called creation by fiat (word) ex nihilo (out of nothing). But think about it, and you realize that **only God can do that**. To treat a human or group of humans (bankers) as though they have the ability to call something out of nothing is to treat them as though they are god and to invite them to rob and eventually to destroy you. God grieved how Israel “made idols for their own destruction” or “that they might be cut off” (Hosea 8: 4) It seems to me that to knowingly do that would make one guilty of idolatry and theft (see the Westminster Catechism quote above). Commercial lending thus robs and oppresses people. Idols always oppress but God says He will in His own time judge and way destroy all idols. Read more about this in **Idols for Destruction** by Herbert Schlossberg which also treats our sinful forms of currency and banking as idolatry). The inevitable result of America’s treating men as though they were god is that all of us are suffering under a very heavy burden of debt oppression. **Only God should be treated as God.** Make no mistake, **America is held captive**. The Bible’s book of Nehemiah (chapters 5 & 9) records the sad story of God’s chosen people (Israel) being “in the land” of liberty God gave their fathers, yet effective “slaves” in it due to their sins and the resulting captivity. This largely parallels our situation in America today. Even secular humanists at CNBC reported on June 25, 2012: **“We are absolutely slaves to central banks”**. And bankers want to bring to fuller manifestation and power (military, industrial, economic, environmental) the “effective global government” already being run by them. If one feels he has no other choice than to seek a commercial “loan” because the bank masters are so in control, he ought to cry out to God’s Son Jesus to forgive us for our sins and to save us from them and from such oppressors (who usually come as judgments from God for sin- read the Bible’s book of Judges). To become a slave and surrender one’s estate (or America’s estate) to be plundered (all our labors expended in effect ultimately for nothing) for a banking system that is anti-God, anti-Constitutional and anti-American and bent on creating a new world order off the backs and sweat equities of others is against God’s word and most undesirable in light of it. So, do what you can to prevent this. Find ways around commercial loans. Rent, locate private IOUs/mortgages from those who will really loan for a time some of their own hard earned assets in exchange for interest for letting you use their money and putting it at risk, ETC. The fraudulent banking system that creates loans and money out of nothing and gives the people nothing for something (their hard labor for years) not only defrauds the people, but also enables the fraudsters/banksters and corrupt government to fund and promote incredible evils and injustices such as abortion, secular humanist education, homosexuality, attacking Christianity and other unconstitutional activities,

commandment in Exodus 20, on which see Westminster Larger Catechism Q & A's 140-142; Ephesians 4: 28; Philemon; Iceland reportedly declared such a Jubilee; Jesus was sent by God to be our “Jubilee Incarnate” foremost for our spiritual/moral debts (eternally more important) but as Scripture shows, when a nation turns to Him, a happy result will be experiencing Him as their Jubilee Incarnate economically as His laws become theirs; **2) restituting** the stolen property (see Exodus 22 which gives restitution rates for thieves without conscience; Leviticus 6 gives restitution rate for thieves with conscience; Luke 19: 1-10. In America, part of this restitution per Scriptures e.g. Matthew 10: 9 (as taught by such founders as Rev. John Knox Witherspoon in his Essay on Money) requires return of gold, silver and copper coin **as soon as possible** (as the supreme human law of the land -the Constitution -already requires in Art. 1, Sect. 10).

8. **So, God’s word clearly calls us to:** 1) repent; 2) require sinners¹³ enslaving hundreds of millions in fraudulent debts to **release/shemitah** them. Such fraudsters ought to do so voluntarily (because the Lord Jesus Christ said so), or, Congress and the courts ought to do so because He requires them to (as does their oath to uphold de jure Constitutional government), or Scripture reveals God as Enforcer can bring it about some other way. As known by Scripture and witnesses confirming His judging us, we have - as always - set before us **knowledge that requires a response** that can either **1) involve jubilation and salvation** by turning to Jesus as we experience Him as our Lord and Savior; **or**, by ignoring God’s call, we choose a path that will **2) involve more judgments** where we experience Him as just Judge and righteous Avenger. Moses said: “See, I have set before you today life and good, death and evil,... and .I call heaven and earth as witnesses today against you, that I have set before you life and death, blessing and cursing; therefore **choose life**, that both you and your descendants may live”. (Deuteronomy 30: 14-20).
9. While I do not claim God **is** enforcing the **7 year cycle** He gave Israel, **I FIND CERTAIN THINGS REMARKABLE IN MY GOD’S PROVIDENCE:** **a) God in His providence brought brother Cahn to an absolute certainty that 9-11-01 and 2008 WERE both judgments from Him. Because I knew both were because I prayed for them and God answered, as others can attest, this was absolutely confirmatory to my soul - praise God - despite my failure in belatedly sharing the message of 911 with President and media (after forgetting my prayer for a time- see www.anchoroftruth.org, God graciously allowed the message of judgment to come - at least to some degree - to the masses of my country which is suffering judgment AND brother Cahn was preaching for America to come back to Him in light of the good news about Y’shua (safety/salvation). every way!); for this too I praise God; **c)** *I find it remarkable there was a 7 year span between 911 and 2008's prayers and judgments and that God led me to pray in 2008 for what resulted in a Great Recession.* **d)** that through Cahn God as well brought to light the biblical principle that these judgments called government and bankers to repent. Scripture faults men for not recognizing God's judgments. So, bankers, a compromising Congress as well as extremely corrupt¹⁴ courts should indeed have repented after 911. The wrath of God is being revealed from heaven and pastors like Pat Robertson and Jerry Falwell called us to repent, declaring God had judged us in 911 and had removed our protections. Amen! At the same time, I here do my God given duty to call on the Most High Authority - the Lord Jesus Christ- to please mercifully enforce His justice and righteousness¹⁵ if the lesser magistrates don't and when He thinks its right.** Just the fact God allowed a 7 year gap between 01 and 08 and the fact that He led a servant of His to draw attention to it should make us all consider before God how His Scriptures require us to **1)** lay down our spiritual and moral debts (sins) at Jesus'

Noah's flood) so Genesis to Revelation praises God for His judgment (Ps. 96; Rev. 19).

feet and find release/forgiveness there (alone), and **2)** have the same occur in the economic realm as required by God. *Fraudster, thieving bankers and partners (Congress and the courts - cf. Isaiah 1: 21-23) -cancel all such debts!* Despite repeated calls and judgments for this, America has not yet given up its sins/moral debts nor the bankers/government their debts whereby they enslave the American people. Judging by God's word then, the prospects for judgment in the economic realm **are staggering**. **Twice** already He judged our materialism: in the Twin Towers and in the Great Recession. Scripture tells us: **1) God graciously provided the full atonement and release** for all the sins of all those who trust in Him and His Son. As seen by Isaiah 9: 6-7 et al (see www.godblessisraelministries.com) Jesus as the God-man paid by His sufferings the ransom for the souls of sinners like ours, a ransom which no one else can or could ever do had they all eternity to try (Psalm 49; Isaiah 52: 13-53: 12; John 14: 6; I Timothy 2; I Peter 1); **2) we then can by God's free and lavish grace repent and believe on Him and show the fruits of our repentance.** God commands us to show we really trust Him to be our God by doing as He commands: get rid of everything from our individual, family, congregational and national lives that breaks His law, learn to do what is right and do it with all our heart! Idolatry, abortion, all immorality, Federal Reserve Act/paper currency, fraudulent loans all must be canceled! But those are only some of our national sins. I leave it to faithful pastors to preach the whole counsel of God wherever they are to the various sins needing exposure and repentance. ALL sins must be turned from for Jesus is Lord of all of life and the world. Just as surely as He **will** bring more judgment if we do not repent, so surely He **will** restore the years the locusts ate **IF** we do repent (Joel 2: 25). HALLELUJAH!

20. **But realize, you need a Savior. Read Romans and you will see:** God is good. Our problem is that we are not. Ever lied? Stolen? Lusted? Desired some part of God's creation more than Him? By nature we are liars, thieves, adulterers and idolaters. Then when you stand before God – a righteous Judge - will He find you guilty or innocent? Guilty! Where do the guilty go- heaven or hell? Hell. **We all desperately need a Savior!** The Bible says: "*...the wrath of God is revealed from heaven against all... unrighteousness of men.*" (Romans 1: 18)¹⁶ By judging in history, God reveals His hatred against sin and reveals that our sinful rebellion deserves eternal punishment (Genesis 2: 17; Romans 6: 23). Such judgments are **unusual**¹⁷ because He fills our lives with sunshine, rain, food, breath, health and so much more. Though we are sinful, He has been SO long-suffering. **But that goodness and long suffering must lead us to turn from our sins. And His judgments seriously warn:** God is angry with sinners and will punish and burn them in hell forever unless they repent and are saved. So we **need a Savior** able to take care of our sins and to rescue us. Jesus alone is that Savior. He alone by Himself¹⁸ can and did the work

Scripture makes it clear that **God and God alone** can and does provide salvation for us from sin and all its consequences- see Genesis 3: 7-21 (especially 7 & 21); 22: 7-8, 14: "And Abraham called the name of the place, The-LORD-Will-Provide; as it is said to this day, "In the Mount of the LORD it shall be provided."; Leviticus 17: 11; Psalms 2, 49, 65: 3; 118: 22-29; and particularly Isaiah 52: 13-53: 12 especially vv. 6, 10-12; Hosea 5: 13-6: 6: 3 and 3: 4-5 (and Ezekiel 36: 16-28 shows His Spirit will be the cause of this); Daniel 9: 24-26; Zechariah 3, 12: 10-13: 1; Luke 15: 11-32; John 3: 1-18; 4: 10; 17: 9 & 18: 24. Man thus receives this salvation by grace alone through faith alone apart from his own sin-tainted works

of saving sinners like us. It is not by our works as all false gospels and false religions teach¹⁹ but by His gracious, free, compassionately providing His only Son to both live and die for sinners -Jew or Gentile- like us.

21. Though we deserve hell, God so loved the world that **He “gave His only begotten Son so that whoever believes will not perish but have everlasting life”** (John 3: 16). God's Son became a man **so that** 1) He could obey God's law for us who broke it in Adam and in our own lives; 2) so that He could suffer the horrifying death and curse sinners like us deserve. Because we broke His law, we could not/cannot keep it to get right with God. Neither could we endure eternal, divine wrath – only Jesus who was both fully God and fully man could. In love, eternally greater than Rescuer or fireman on 911, Jesus accomplished every thing- obeyed all the law and suffered all the penalties for our breaking God's law.
22. God, having graciously provided Him for just such sinners as us, assures us that if we will turn to His Son to save us out of our sin and misery, **HE WILL!** God will become our loving Father in Jesus and we will enjoy His presence, care, protection, forgiveness, and His face shining on us like warm sunshine. **All because of Jesus.** Salvation is a free gift of grace, entirely unearned, received as a gift. Sure we have to run away from sin - like those running from a burning building. If we feel ourselves chained to sin, Jesus may be called on in prayer for deliverance . Earnestly and sincerely look to Him in all your weakness and ask and then depend on Him to forgive, save and make you right with God forever. He promises He will: *“Seek the LORD while He may be found, call upon Him while He is near. Let the wicked forsake his way, and the unrighteous man his thoughts; let him return to the LORD, and He will have mercy on him; and to our God for He will abundantly pardon.”* (Isaiah 55: 6-7).
23. God gave assurance of His Son's claims by raising Him from the dead 3 days after He died²⁰! **And by His making predictions and bringing them to pass!** Jesus' resurrection was predicted **hundreds of years** before it occurred in the Old Testament/Tanach (see Psalms 16, 22, Isaiah 52: 13-53: 12, Hosea 5: 13-6: 2 et al), and so were **hundreds** of other parts of His life. Daniel 9: 24-26 foretold **WHEN** Messiah would come in history: namely, **before** the 2nd Temple's destruction (which was in **A.D. 70**). Details of Jesus' ministry, death, resurrection and exultation were all foretold as shown below. **ONLY THE CHRISTIAN BIBLE HAS SUCH FULFILLED**

-Genesis 15: 6 (God declared Abraham righteous before he was circumcised in obedience to God's commandment - 17: 11,26; cf. Psalm 33: 1-5; 34: 22; Habukkuk 2: 4; Romans 1-12; Ephesians 2: 8-10 et al. Now that Jesus died the death His people deserve for their sins, we who trust in Him are forgiven and stand right before God (Psalm 2: 12; Isaiah 53: 11-12).

19 **I swear to God** that after watching **“A Lamp In The Dark: The Untold History of the Bible”** and its sequel **“TARES AMONG THE WHEAT”** about the Roman Catholic Church's false gospel that sends people to hell, I prayed that the Lord Jesus would show His wrath towards that false church both by causing its pope to resign and by striking its Vatican not just once but twice with lightning. About a week or two later I heard or read in the news that both had happened. Reported by <http://www.mirror.co.uk/news/world-news/lightning-bolt-hit-vatican-not-1705156> that some considered it “to be a sign from **God**” I say yes it was! Loving my neighbor as myself means seeking to warn those trusting in their/others works not to but to trust in Jesus of Nazareth alone! I am not boasting- Jesus just really has answered these and other such prayers as well as prayers for people's salvation, healings, spouses, children, prosperity and more – because He is alive! So I give my personal testimony confirming that **Jesus is God** and as He through His apostle Paul teaches in both Romans and Galatians (chapters 1, 2 and 5), He 1) warns that He curses those who teach anything but “the truth of the gospel” that salvation of sinners occurs by grace alone through faith alone that looks to Jesus alone to save, and 2) warns that those who trust (or show by their works that they trust) in their or other sinner's works to save them **“have fallen from grace”**, are **“debtors to the whole law”** (you have to have never ever sinned past, present or future and must perfectly from the heart at all times keep all God's laws if you want to be saved by your own works- impossible- for we all already broke God's laws in Adam- Genesis 3/Romans 5) and that trusting in your own works at all to make you right with God result in this: **“Christ will profit you nothing”** - you will perish in hell. Knowing this from Scripture and Jesus' answer, why should I not warn people so that on judgment day they do not stand among those who will perish? Let all know that Jesus is alone the all-sufficient Savior and that having Him we need nothing else and no one else to approach God. Both the hymns: “Not What My Hands Have Done” and “Come to the Savior Now” assure us of these happy truths.

PROPHECIES. God claims only He can predict the future (even years before it occurs) and bring such predictions to pass. All other religions and gods utterly fail this test (see footnote²¹):

24. **How will you respond?** God's prophet Joel both warns you with God's justice and woos you with His mercy "...strong is the One who executes His word. **For the day of the LORDⁱ is great and very terrible; who can endure it? "Now, therefore," says the LORD, "Turn to Me with all your heart, with fasting, with weeping, and with mourning."**....Return to the LORD your God, for He is gracious and merciful, slow to anger, and of great kindness; and He relents from doing harm." Perhaps this warning provokes you to anger. That is a sinful nature response. Consider God's goodness to you: how He created you and upholds your life. You breathe His air, drink His water, eat His food, walk His planet. He is still being good to you **right up to the present**. Praise Him! And now think, He gave **His own Son, Jesus, the One whom He loved**, in love and compassionate concern in order to die in the place of sinners like us! Knowing that God has already graciously provided forgiveness, acceptance, joy, and life everlasting with Him through His Son frees us to admit that we are guilty, that we can't ever earn God's favor or approval by our own lives or efforts and to entrust ourselves to the most loving and gentle Savior we could imagine! Knowing this gracious provision of God in Jesus tenderly assures and invites us to freely and fully depend on Jesus, committing ourselves to Him, believing Him to do as He promised: receive and save all who call on Him to be their personal Lord and Savior. Our situation is desperate but He is so desperately good and has already done **everything** we need to be right with God! **Allow God's goodness and promised of pardon to draw you to Him.**

1. **Yes, God is graciously ready to pardon our sins!** Psalm 86: 5: "*For You, Lord, are good, and ready to forgive, and abundant in mercy to all those who call upon You.*" "*Come now, and let us reason together, says the LORD, though your sins be as scarlet, they shall be as white as snow; though they are red like crimson, they shall be as wool. If you are willing and obedient, you shall eat the good of the land*" (Isaiah 1: 18-19).
2. **Yet, God is righteously ready to pour out wrath for our sins!** So far, America has not repented! 3 times our so called leaders uttered Isaiah 9: 10's words in response to 911 judgment proving our defiant, unrepentant spirit. As we saw earlier, God through Isaiah thus gives us reason to expect **greater judgment**: (see again Isaiah 9: 11-14, page 1). 22 This reminds me - God answered prayer against abortion and fetal experimentation earlier too. On Jan. 18, 1998 I preached "Abortion, America and Judgment" at a church in New Jersey from Ezekiel 14: 12-23. I said: 1) abortion is murder by which nations incur bloodguilt and a death sentence for unrequited innocent bloodshed; 2) Amos 1-2 proves God's patience runs out with nations. Sickening atrocities (like gutting a woman's child from her) then and now greatly arouses God's wrath. 3) God is greatly angered when government entrusted with the sword does not use it to protect innocent life, but helps slaughter it. **God will send judgment** on our land like He has other civilizations. 4) I detailed sickening atrocities Clinton was directly involved in including the ghastly bloodguilt of millions of unborn children and the ghastly, Nazi like experimentation on the living children who survived their abortions- all to advance "science". 5) Scripture says we **must expect** judgment for this. 25. For further reflection:

1. Does your conscience tell you you've sinned against God? What has God SO graciously done for sinners like you to provide a solution to your sin problem?
2. Do you know what you must do to be saved? Will you do it?
3. Do you believe God will forgive you if you turn to Jesus BEFORE either a judgment or regular death calls you before His throne? Are you ready right now to appear before God? Would you go to heaven or hell if it were now?
4. Given that you do not know when you will die, no guaranteed next breath, do you care for yourself enough not to risk dying and being eternally separated from God in hell forever due to putting off turning to Jesus today?
5. Will you repent of your sins and call on and trust in Jesus to be your Savior and Lord?
6. As a sign of trusting obedience to God, will you seek a faithful, evangelical church to worship Him with each Sunday along with His believing people?
7. Why do you think God allowed our nation to become enslaved to fraudulent debts/bankers? Why does He allow Congress and courts to perpetuate the fraud? (Hint: read Judges).
8. Are you thankful God offers forgiveness in Jesus? Requires cancellation of fraudulent debts?
9. Will you call on Jesus to deliver our nation from our moral debts as well as fraudulent debts? Will you re elect the 56 who voted for Planned Parenthood funding after abortion's evil was put in our faces by God? Call for restoring Constitutional a) gold & silver and b) government?
