 This is a petition for redress of grievances that: 1) comes by the authority of God's law, Christian common law, America's supreme law, analogous Statutes at Large 48, 48, 112 as well as your 26 USC 7433 et al and at the direction of God both by His answers to prayers for acts of judgment and of mercy; and that: 2) if not answered with redress as required by law and contracts will according to God's word result in His enforcing (in His time and way) the mandatory sanction the general equity of said laws require, namely, many guilty parties to "suffer death": you, others in government and Americans for decades of rebelling against Him and said laws.

- 2. Like most in America, this court is almost certainly grossly ignorant of God's law, unacquainted with His ways as well as ignorant of His recent righteous acts of judgment against America and its government for our three and four great sins, judgments given in order to call us to return to Him;
- 3. said lives being at risk, this matter must be **patiently read and reviewed** if the reader will not

be guilty of endangering said lives.

- 4. God's word reveals His standard operating procedure with nations: after "three transgressions...and four" He "will not withhold punishment" but brings such punishments as fire to capitals and military and even finally "destroy"s nations who shrug off God's warnings, thinking they will not be destroyed (Amos 1-2; 4:1-5:1; 9:8 et al).
- 5. The record shows America and its government: 1) **are guilty** of breaking the same laws of God ancient Israel was "destroy"ed for: a) idolatrous "separation" from God (Isaiah 1; 59 et al); b) murder of children (Psalm 106; Isaiah 1 et al); c) gross immorality (Isaiah 1 et al); d) fraudulent currency (Isaiah 1 et al) resulting in gross but hidden rights violations; 2) **recently suffered** God's judgments (911, 2007's drought, 2008's Great Recession, 2016's drought and fires et al) for said lawbreaking which came as God's answers to prayers prayed by the author and or other saints to spare this nation greater destructive judgments;

Respondents gave written acknowledgment to the government's owing me "dollar for dollar" refunds as just compensation for taking my private property yet "changed" said refunds without authorization into alleged debt taxes, thereby putting themselves under the mandatory "suffer death" penalty the general equity of said law authorities.
- 7. This refund matter is a perfect illustration God set up of our fourth sin that: 1) follows after the unlawful foreclosure of our house which our courts approved of despite evidences of gross frauds, gross rights violations and warning that God may send further judgment for said 3 and 4 sins (and did send 2016's drought for), thereby indicting themselves of said fourth sin and thereby gave God ONE FORMAL WITNESS that America and government flagrantly defies His call to repent of our 3 and 4 sins though warned God threatens destruction; 2) will give God a SECOND FORMAL WITNESS that America and government persist in flagrant defiance against God this court does not rule in my favor as laws and contracts require; because God only requires 2 or 3 witnesses to prove a matter, this court's ruling in this matter will either give God said second formal witness or indication of a step in the right direction.
- This matter shows the federal government owes the author \$3,___ in refunds pursuant to requirements of God's law, Christian common law, America's supreme law, Statutes at Large 48, 48, 112, contract law and or other relevant law and or statutes; yet that government without authorization of law and in violation of law converted said refunds into alleged tax debts.
- 9. This matter shows **the federal government owes me §**_____ **in other funds** pursuant to the requirements of God's law, Christian common law, America's supreme law, and or agreeable and or analogous statutes such as 26 USC 7433 as well as contract law for failing and or refusing to provide authorization for its having "changed" said refunds into alleged taxes and or for failing and or refusing to rebut timely sworn assertions mailed to them.
