EtAl I will be making use of **Exhibits 33, 33.5 and others** as proofs **that in the context of law and history** illustrate 12 clear and indisputable truths which I have summarize for the reader here:

1) Said Exhibits prove that my and the IRS' calculations for my refund **matched**, they agreed; get this: in writing the IRS approved of and agreed that my 2008 1040 and its 1099 OID supports (shown in Exhibits _____) rightly/lawfully showed I was owed \$120,001 in refunds/credit for 2008; (they also did this expressly or indirectly with years 2005, 2006 and 2007); God's word at Psalm 64 shows men ought to consider and fear God for He caused them thereby to stumble on their own tongue; they did not send my 1040/1040Xs back asking "We never saw this before- what is it?" no, as reported to me tens of thousands of other Americans processed for refunds on the same grounds and using the same process and IRS forms and received them (1 of which swore under oath in God's Name he received such refunds - see Exhibit ___); so realize: the IRS in writing acknowledged/agreed with the reality of my law based refunds,

2) Because said 3 laws, logic and a native sense of justice (for those still having an unseared conscience brought about by giving themselves over to lawbreaking) show there is no possible right, reason or authority for the IRS to **tax a credit**, therefore it without authorization taxed my refund/credit and "**changed**" my credit/refund that their own writing admitted was owed me and was in my "**Account**" into a debit/tax debt; I am a seminary trained minister with a clear conscience in this matter but **anyone** with a clear conscience who wants to deal honestly with God's moral law and or any law of man agreeable with His law knows **no one** has authority to "**change**" someone's refund into an alleged tax; if they have no moral authority (to do so), they have no authority/their act was immoral/unlawful; the IRS's criminal act in this parallels Judah's criminal princes in Jer. 34 who likewise admitted the law required them to "**proclaim liberty**" to their slaves but the record shows they too "**changed**" things too so as to avoid proclaiming liberty to their slaves and to return them to slavery- only to be their permanent involuntary slaves where the mandatory death penalty of God's law then required those in government to suffer death (Ex. 21: 16; Deut. 24: 7; Amos 2: 6; 8: 6; 1 Tim. 1: 10ff; Heb. 2: 2 et al) for stealing a man's life (his labors, energies and time) also known as "**man-stealing**" or enslaving.

3) Even the IRS' **math** shown in said Exhibits confirms the truth that the IRS was required by law (God's law at Ex. 20; 1 Chron. 21; et al- what the Declaration of Independence in the words "**the Laws of Nature and of Nature's God**" says America and its right/authority as a nation and government are based on; America's law at Fifth Amendment's "**just compensation**" guarantee and Statutes at Large 48, 48, 112 et al) to acknowledge the rightness and lawful reality of the refund/credit owed me; for even while their writings show they capriciously and without authorization assigned the 159,027 amount as an alleged tax, the same writing still also shows they nevertheless had to respect the lawful basis and accuracy of my refund/credit owed for they treated that 120,001 as a credit/refund truly/lawfully owed me for they subtracted it from their alleged tax of 159,027, and, after they as well added unauthorized interest of \$201.52, they arrived at their alleged net sum of 39,227.52 of alleged taxes for me to give my funds for.

4) Therefore all of the IRS (and the State of Alabama's as a franchise, territory and or subsidiary of the US government/District of Columbia/D.C.'s) debt collecting acts were entirely without any authority from law but were instead entirely **unauthorized and unlawful**;

5) Like **DNA** of hair or blood at a crime scene that matches a suspect's hair or blood sample later, so in this matter. Already we have seen that in the very Exhibits where the IRS demands of me "**\$39,227.52**" in alleged taxes, they admit I am actually owed a refund, and, that they had no authority to tax my refund and "**change**" it into a tax. BUT that DNA in their first letters matched and repeated itself in the IRS' further letters in which they wrote me over and over about my owing them for 2008. In those later letters, what did they do? They continued to give the same numbers as in **Exhibits 33, 33.5** et al, where their numbers had been calculated and based on the premise and truth that I was owed the \$120,001 refund but as well that they had without authorization taxed my refund, "**chang**"ing it into a tax.

6) **Exhibits 33, 33.5** for 2008 confirm the lawful validity of the refunds owed me for **the other years** of 2005, 2006 and 2007. To see this, one merely needs to review my Exhibits of my 1040/1040Xs for years 2005, 2006 and 2007. These prove that all said four years were based on the same truths, facts and premises in law and

followed the same calculations process to determine the refunds. Therefore, because the IRS admitted in Exhibits 33, 33.5 concerning 2008 that I was owed 1099 OID “dollar for dollar” refunds, we know from good and necessary inference that it is as well true that the IRS owed me the 1099 OID “dollar for dollar” refunds that my 2005, 2006, and 2007 1040/1040Xs showed I was owed given that those three years followed the same truths, facts and premises in law and calculations process used to determine the refund owed me for 2008. In confirming this are **Exhibits** _____ of IRS writings confirming in writing the refund amounts owed for 2005.

7) Because **Exhibits** ____ show I wrote and by the laws of God and man required of the IRS and superior government officers lawful authorization for: (A) their “change” and denial/withholding of my refunds as well as for (B) their debt collecting acts, but the IRS and said superiors refused and or failed to give any such authorization, and the IRS further wrote that my claims were “frivolous”, it is clear that the IRS and said superior officers **contradicted** the former writings of the IRS that in writing admitted that my sworn to be true/lawful 1040/1040Xs with supports were true/lawful.

8) Because **Exhibits** ____ show I wrote and by the laws/rulings of God and man required of the IRS and superior government officers EITHER timely to rebut my sworn assertions (both in my 1040s/1040Xs and in my AFFIDAVIT OF TRUTH & FACT) with particularity if there was anything wrong and or inaccurate about my said sworn writings, OR to implicitly agree/acquiesce to the fact that my sworn assertions were all true, correct and lawful, therefore because the IRS and superior government officers failed and or refused timely to rebut my sworn assertions, therefore the laws/rulings of God and man require that the IRS and superior government officers agreed and acquiesced to my sworn assertions and formed **implied contracts** to my sworn assertions. *[[[[[[Defense: even though the IRS contradicted laws and their own writings and even though this court ruled my claims were “frivolous” my trump card is God's word that declares that even if I had made “rash” sworn assertions, once the IRS and Rs failed and or refused timely to rebut them with particularity of witnesses of law, facts and evidences, those sworn assertions that were proposed implied contracts “stand”, are “binding” and must be “do”ne as His word on the matter in Num. 30 requires!]]]]]]*

9) Said **Exhibits** illustrate our **lawbreaking rebellion** against God (as Israel in Isa. 1; Matt. 27:25; Acts 2; Rom. 9-11) and of government's having become corrupted by unjust currency so it involves itself in “every species of fraud and injustice” even as Israel's prophets and America's founders warned. They dare to plunder refunds that in context of laws and history were to proclaim a measure of liberty to me.

10) Therefore God's hand of providence has illustrated by said Exhibits in the historical circumstances and in light of His word at **Jer. 34** how ancient Israel and modern America parallel each other where although government was to “proclaim liberty” to slaves to prevent permanent slavery of any sort of His people, in both cases government acknowledged their duty under law to so proclaim liberty, in effect did so momentarily, but then “changed” the liberty to bondage, thereby “profan”ing God's “name” they swore by so that now we are on the BRINK of hearing these words from the God whom America professes to “trust”: “thus says the LORD:” “You have not obeyed Me in proclaiming liberty, everyone to his brother and everyone to his neighbor. Behold, I proclaim liberty to you,’ says the LORD- ‘to the sword, to pestilence, and to famine! And I will deliver you to trouble among all the kingdoms of the earth. And I will give the men who have transgressed...the words of the covenant which they made before Me...the princes...and all the people of the land who [entered covenant by oath/affirmation I will give them into the hand of their enemies and into the hand of those who seek their life. Their dead bodies shall be for meat for the birds of the heaven and the beasts of the earth.” Our only hope of escape is repenting and faith in God's Surety, namely Jesus the God man who alone could and did bear the just, eternal wrath of God against such lawbreakers.

11) By good and necessary inference, because I as an American was rightly owed these “dollar for dollar” refunds, so were/are the rest of Americans though ignorant of this. **All Americans** who had their gold taken from them and were forced to take Federal Reserve Notes are due to have these refunds given them in order to effectively “proclaim liberty” to them (Lev. 25: 10 on the Liberty Bell).

12) Said **Exhibits prove in context - given** our history, laws and Supreme Court rulings as well as recent Public Laws all affirm that America made covenant with God, that we based our laws on His word and that it is our duty

to trust and obey Him, **given** God's word's Standard Operating Procedure with nations that for persisting in “*three transgressions and for four I will not withhold punishment*” (Amos 1-2; Ezek. 14: 13; Rom. 11: 22), **given** that our courts gave God a **FIRST FORMAL WITNESS** of persisting in the same 4th sin Northern Israel was “*destroy*”ed for (cf. Isa. 1; Amos 1-2; 9: 8 et al) as illustrated in the unlawful foreclosure and theft of my house (though courts were informed that house was directly connected by God's providence with 911 for our 3 sins and that the case with our house illustrated our fourth sin, **given** this court already expressed “*fraud and injustice*” by dismissing my previous petition for redress of grievances by citing *US v Perry*, **given** that God's law and court **only requires** “*two*” “*witnesses*” **to prove a matter where He can then pronounce and send what His** word warns will be “*severe*” (Rom. 11: 22) “*punishment*” (Amos 1-2) **IF** this court as part of this government-banking syndicate dares in this matter that illustrates American government's fourth sin, it will give the holy Creator a **Second Formal Witness** that this 1 court dares – though it has been informed of all it is informed of herein - to PERSIST in our fourth sin (after we have also not repented of our 3 sins) – to rule other than entirely in my favor as law and contracts require then it will show our Almighty Creator God who in answer to prayer through His “*Savior*” “*Jesus*” gave America courage to stand on His “*Law*”, to declare freedom/independence from its own oppressive government and to win the war against its oppressive government and will show that instead of accepting free reconciliation with our Creator God through Jesus who sits exalted at His right hand so we and others may be superably blessed, it will as it were raise and shake a curled fist against Him and His Son and defy Them to send the “*wrath*” that His word and our own post-911 Law 107-293 says He will pour out on us, even the “*severe*” “*punishment*” His word teaches, which teaching Congress in its 1982 Public Law 97-280 urged America and government to “*study*” and “*apply*” so we may strengthened in faith and obedience and so to be further blessed by God.

13) *I learned in 2019 that a man knew of these 1099 OID refunds years before but did not pursue them for he learned those who sought them got into trouble with the IRS. Though I did not know him at the time, when in 2009 God led me to the 1099 OID refunds by striking answers to prayer, His special providence and the gifts of the Holy Spirit (all of which I tested and found agreeable with Scripture), I concluded that Scripture showed **I had no other choice than to seek them; nor, given the answers to prayer God gave me, did I have any other choice than to bring this FleshingOut as I have. “Woe is me if I preach not the gospel” in this matter God gave me (1 Cor. 9).***

14) Gospel means good news: *as Israel's prophets pointed to God's word and things God had shown them giving stern warnings yet also gracious promises, so do I point to God's word that God confirmed by answers to prayer, gifts of the Holy Spirit, world history and His providence in this matter. Said Exhibit 33 et al proves in context of all of that the great debt the IRS and its masters in the banking-government syndicate owe God for breaking all said covenants/contracts and said laws. I prove herein by God's word, “act”s and the conspicuous fingerprints of His providence that America and its government banking syndicate in particular are on the brink of “severe” “wrath” and “punishment”. Indeed, the whole world seeming to be guilty of these four sins is worthy of wrath, how much more the captor/leaders guilty of bringing nations under them? Yet the good news is the same for any and all: Psalm 49, Isa. 53, 55 and God promises and His answers to prayer relating to all this matter confirm His word that He is ready to pardon and pour out not only temporal but eternal GRACE and blessings on Israel, America and the nations as they remember their Creator, the covenants they had or have with Him, His moral law binding them, and their duty to be reconciled to Him through Jesus Christ.*
