

## **Watchman's WARNING: your life and of Americans is in DANGER!**

- **How this matter affects you:**

- Though I have ever sought for America to be blessed (Prov. 14: 34) by being right with God, America has persisted for decades in rebellion against God and His law; God sends “wrath” for this just as His word, His dealings with Israel and other nations and 2002’s (post-911) Public Law 107-293 warns;
- God’s word gives His standard operating procedure with all nations in Amos 1-2: “for three transgressions...and for four, I will not withhold punishment” where the word “punishment” shows He often already gave lesser judgments (cf. Amos 4) but because the nation persists even in 3 and 4 sins, He sends severe punishment which context shows involves His sending fire on capitals, cities, “gates” (military and government), and taking huge numbers of lives
- Isaiah 1 shows ancient Israel and America are guilty of persisting - over the warnings of God’s ministers and saints- in what God’s word calls “four” “mighty” “transgressions”/acts of lawbreaking: idolatry, abortion murder (and now Obamacare), immorality and unjust currency that results in unjust government- guilty of the “every species of fraud and injustice” as prophets and founders warned
- God often confirms the word of His servants (Heb. 2 et al) by causing their words or things in their lives to illustrate truths He is having them preach about; that is the case here, and confirms and illustrates the glaring illustration of America and especially government’s fourth sin of unjust currency and the unjust acts it brings government to do
- God’s people are required to pray “all prayers” (Eph. 6: 18) for God to spare their nation yet also as a last resort to pray for God to intervene when government refuses to redress grievances; this is why Elijah prayed and God gave a drop of His wrath in 3.5 year drought that brought people to the point of starving to death (James 5: 15-18) so as to prevent greater wrath on nation (“destr”uction- Amos 9: 8; Rom. 11: 22) and individual souls from hell. Such stripes are used by God to call men and nations to repent and if they will receive instruction, they can turn from their hell bent ways. After praying for decades for our nation to be spared, I finally resorted to asking God for a drop of His wrath to America back to God; about a ½ hour before anything happened on the morning of 911, I prayed the prayer shown at [www.anchoroftruth.org](http://www.anchoroftruth.org) because though we claim “In God we Trust” we truly trust in our idol of money/materialism and military might and went on murdering our unborn day after day, week after week, month after month, year after year, decade after decade. I asked God if He thought it right to perhaps allow our Pentagon and Twin Towers to be attacked to call us to repent and return to Him through His Son Jesus whom He gave in love for sinners like us so 100s of millions of Americans could be called to turn from their path that leads them to eternal hell and America could be blessed again. God answered as can be known by the authorities I shared with President GW Bush and the media years ago and additional proofs that are at [www.anchoroftruth.org/2011](http://www.anchoroftruth.org/2011) (which will be there shortly Lord willing). I asked God that if He answered He would let not let the righteous suffer but the wicked if they refuse to repent. Pray God enforces that.

- **The Federal Court of Claims did wrong earlier by dismissing my earlier refund claims “as frivolous”<sup>1</sup>.** We are preparing to go to that court again though (led by God to) to flesh out our former

petition for redress of grievances so that they may have another opportunity to uphold the law and order the IRS to do what their own writings and our implied contracts<sup>2</sup> formed with them require.

- Historical context: because America's court system gave God a FIRST FORMAL WITNESS that it refuses to repent and persists in our nation's fourth great sin of unjust currency with its resulting "every species of fraud and injustice" this matter well illustrates, IF the Federal Court of Claims again responds by doing other than ruling in my favor to uphold the law and these contracts, that will give God a SECOND FORMAL WITNESS. All it takes to prove a matter to God is two witnesses. SO if after God answered prayers for 911, 2007's drought, 2008's Great Recession for our 3 sins of idolatry, abortion murder and immorality and He has answered as well prayer for judgment in 2016's drought and three dwelling fires further courts like in ancient Israel's day from "least" to "greatest" all did wrong and refused to turn from this fourth sin and its "every species of fraud and injustice" as epitomized in parable form in our house which was stolen from us by court approval using forged documents, no right to trial by jury, etc, it is clear **God's word THREATENS and WARNS of MORE WRATH.**
- God led me to realize our fourth sin by leading me to seek refunds for government's taking of gold coin and forcing use of debt instrument currency (1 Chron. 21; Fifth Amendment; Statutes at Large 48, 48, 112) and as Exhibit 33.5 (and others at [www.anchoroftruth.org/2011](http://www.anchoroftruth.org/2011) (which will be there shortly Lord willing) proves they like Judah's princes (Jer. 34) momentarily announced/recognized that I was owed said refunds (a way of releasing me from the permanent involuntary debt slavery Americans have been put under by taking away just currency and being forced to take unjust/debt based currency; a way of "proclaim"ing "liberty" to me but then just as Judah's princes did they wrote they "changed" the refunds/credits into alleged taxes/debits and came after me to debt collect, siezing bank accounts AFTER IN THEIR OWN WRITING THEY ADMITTED THEY OWED US THE REFUNDS!
- So like Jeremiah (20): I shout "Violence and plunder!" showing our government is as guilty as Israel's
- For proof of the righteousness of my refund claims,
  - See Exhibits 33.5 showing the IRS agreed with our sworn 1040 that we were owed refund amount of 120,001.00 for 2008 as confirmed by three witnesses: myself, Turbo Tax and the IRS' calculations)
  - see the fact that God answered my prayers for drought and fire confirms that He recognizes I have no known sin in this matter.
  - The record shows that what Jesus in John 3 said is true of evildoers is true of them: they do not come to the light for they give no explanation nor authorization for their deeds but only use threats (of fines, prison, et al), lies, frauds and oppression to enforce their theft. Despite all I wrote as shown at [www.anchoroftruth.org/2011](http://www.anchoroftruth.org/2011), they keep presenting me bills but never verify them as the law of God (3<sup>rd</sup>, 5<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup> commandments), the founder's Constitution and Bill of Rights (private property, justice, due process, et al), Fair Debt Collection Practices Act, et al requires and fail to provide verified documentation per 26 USC 6505 ("under penalties of perjury") of their lawful assessment and delegation of authority. Because I found this to be true over the years, I asserted it under oath and though they were required to rebut me timely with particular and relevant witness of laws, facts and or evidences, they have failed and or refused to. Thus according to God's word a term

was made that “*any alleged tax debt shall forever be considered...nothing owed*”. I further formed contracts with the State of Alabama, a US government subsidiary that: “*all my contracts with IRS...are also contracts with you, and all obligations with them are obligations as well with you...where... “any court” in America is obligated “immediately” to enforce in my favor as required by God’s law, contract law, and Constitution Art 1 Sec 10.*”

- Thus the record shows that while I prayed for 911, 2007’s drought, 2008’s Great Recession for our 3 sins, now God is illustrating (as He did by His prophets/ministers in Israel et al) our fourth sin, the most dangerous, the one God says is as it were the last straw for any nation!
- God’s word soberly warns all four of our sins deserve death; we owe God “life for life” (Gen. 9: 5-6; Num. 36; Luke 11; Rev. 6: 9-11 et al) so after murdering 60 million of our unborn sons and daughters... woe to our nation! After He has already taken lives in 911, His word and providence clearly WARN THAT OUR LIVES ARE IN DANGER IF THIS COURT GIVES GOD A SECOND FORMAL WITNESS. His word warns that may put us beyond remedy (2 Chron. 36) so God pronounces sentence against our entire nation just as He did after His minister Jeremiah’s one long petition for redress of grievances was rejected by his government (Jer. 36).

**Action points. Please:**

- 1) **Pray** for the Lord Jesus to vindicate us in this matter. Pray for repentance toward God and faith toward His Messiah Jesus in government officials; pray they turn from evil and do right; pray for our protection (we have suffered greatly for speaking and doing according to God’s word: our house was stolen!; so have our refunds been; pray God gives us a voice/platform to be heard widely so what God’s word and “act”’s of judgment have been may be known so our nation may return to Him in Jesus and be blessed!; obey God’s command to pray “all prayers” (Eph. 6: 18) and so also pray as did our founders against their unjust oppressive government the words of Psalm 35.
- 2) **Write** a letter for us to Cleburne County Sheriff urging them not to break God’s commandments, America’s supreme laws, the contracts formed with the State of Alabama and their oath of office. God holds accountable and will punish those who persist in breaking His commandments!

- 4) **Stand** with us for repentance, righteousness and restoration to God through Jesus Christ unto the thankful obedience to Him for His salvation (a gift of His grace in Jesus) that shows our faith by its works of obeying all His laws! Give us your moral support.
- 5) **Share** this watchman’s warning with other Americans in order to obey God’s commands in Ezekiel 3, 33, Acts 20 et al. If we know to do right but do not, we sin (James 4) and incur guilt/blood guilt of souls or bodies God’s wrath takes.
